Introduction

Project Selection

Funding and Allocation

In line with Company's CSR Policy, the Board of the company shall ensure that the Company utilize allocated funds in each financial year, at least two per cent of the average net profits of the company made during the three immediately preceding financial years. The net profit is to be calculated as per Section Of the Companies ACT, 2013. I If the company fails to spend such amount, the Board shall, in its report made under clause (o) of sub-section (3) of section 134 of the Companies Act, 2013, specify the reasons for not spending the amount and shall, appropriate such unspent portion in accordance with second proviso of section 135(5) of the Companies Act, 2013.
